I trust you are fine! Good afternoon.

Reference is made to update number 16, please find following more details re adopted measures -

- One user per telephone set
 - Telephones should not be shared between employees 0
- In the case of retail stores, when a call is received and needs to be passed on to another member of staff this needs to be passed on to the next telephone line, and the telephone the call was received on must be sanitized immediately.
- Telephones must be sanitized after each use in the case of telephones which are shared among 0 staff
- Employees who are currently under a salary bond agreement will have this agreement temporarily suspended, hence no salary bond will be withdrawn from end-of-month wages until further notice. After this period is over, salary bonds which were suspended will come back into effect accordingly.
- We refer to our previous email re: not sending money abroad the company is suspending salary bonds in order to assist staff in Malta due to the imminent lockdown and expects that employees will respect the guidelines given in our email not to send money abroad in order to avoid putting themselves in dangerous situations.
 - Cash advance repayments are still applicable and should be paid on time. o
